

 2. The current Concessions contract I have expired.

3. Multi-media rights (through firms such as IMG, Learfield, Nelligan, etc).
4. The current agreement I have previously received with Pepsi is set to expire in July 31, 2018. If there is an updated contract or amendment, please send, otherwise no need to resend.
5. The current Ticketing contract I have expired.
6. The Trademark contract that was provided previously with CLC may have auto-renewed according to its terms; provided however, if new terms have been memorialized in a new contract document, then I request that new document (such as an amendment or new contract).
7. Video management (through firms such as XOS).
8. Outsourced Ticketing (through firms such as Aspire/Collegiate Consulting, etc).
